In accordance to the orders issued in the reference (4) cited above, permission is hereby accorded to implement the following guidelines:

## Refund policy guidelines for B.Sc. (Hons.) Horticulture and Diploma in Horticulture courses

The notified date of admission i.e., date of commencement of classes will be given by the COE, ANGRAU as it is the combined counselling process conducted by ANGRA. The date of commencement of classes will normally be immediately after the completion of second counselling.

- 1) The student has to pay the prescribed cancellation fee to get the refund and to get back the original certificates as per the guidelines from time to time.
- 2) In case of sliding to other courses during combined counselling (Veterinary Agriculture, Fishers and Food technology) fees will be transferred to respective colleges along with the original certificates.
- 3) In case of admission to other courses other than above mentioned courses refund policy will be the same as mentioned in the table, duly following the guidelines.
- 4) The Refund policy will come into force from 2020-21 admitted batch onwards.
- 5) The above refund policy applied to University fee and Non-University fee only.

Student who paid fee for college admission in 1<sup>st</sup> / 2<sup>nd</sup> and 3<sup>rd</sup> / final 50% 4. counselling and cancelling the seat within 30 days but after 15 days of the notified date for the commencement of classes. Student who paid fee for college admission in  $1^{st}$  /  $2^{nd}$  and  $3^{rd}$  / final 5. No refund counselling and cancelling the seat 30 days the notified date for the commencement of classes.
