Admission into B.Sc. (Hons.) Horticulture under Industry sponsorship quota for the Academic Year 2026-27

INFORMATION BROCHURE

Applications are invited for admission into B.Sc. (Hons.) Horticulture courses in Dr.YSR Horticultural University (Dr.YSRHU), Venkataramannagudem, Andhra Pradesh **under Industry Sponsorship Quota (2% of seats) for the academic year 2026-27.**

The number of seats available in **B.Sc. (Hons.) Horticulture: 8**

Academic Eligibility:

Degree	Eligibility
B.Sc.(Hons) Horticulture	Passed with a minimum of 50% of marks in two years intermediate course (10+2) with Biology, Physics and Chemistry subjects (Bi.P.C) or Mathematics, Biology, Physics and Chemistry subjects (M.Bi.P.C).

- Students admitted under these quota are governed by Dr.YSRHU undergraduate Academic guidelines.

Age:

The candidates for admission to this course in the University shall be required to have completed 17 years of age on the 31st of December, 2026 with an upper age limit of 22 years for all the candidates.

General Eligibility Norms for seats under Industry Sponsorship Quota

Industry sponsorship quota:

Any industry related to Agriculture/Horticulture should be a registered body.

A member of the Agriculture/Horticultural industry can nominate only one candidate for admission to B.Sc. (Hons.) Horticulture course.

The industry willing to sponsor the candidates will be considered subject to fulfillment of the following:

- a) Sales Tax Registration Certificate (TN/GST/CST)
- b) PAN card
- c) Audited Balance Sheet for the last three years
- d) Income tax return statement for the last three years
- e) Certificate of Incorporation
- f) Article of Association / Memorandum of Association
- g) Sponsorship letter (Sponsoring one candidate for admission to undergraduate degree program indicating the degree applied).

Criteria for selection:

- The eligible candidates applied under Industry sponsorship quota shall be selected based on merit in the prescribed subjects in Intermediate / 12th class examination or its equivalent under Bi.P.C/ M.Bi.P.C. stream will be eligible.
- In case of other equivalent examinations passed by the candidates, the weightage of marks /grade obtained in the prescribed subjects shall be reckoned on par with those of the two year Intermediate examination.
- In case of a tie in aggregate marks /grades obtained by two or more candidates, the aggregate marks secured in Biology, Physics & Chemistry shall be taken into consideration. In case of a further tie, the age of the candidates shall be taken into consideration and the older candidates shall be given preference for the merit.

- The payment quota fee structure will be applicable for admission into UG programme.

- If the admitted candidate cancels his / her seat before the closure of Industry sponsorship quota admissions for the academic year 2026-27, an amount of Rs.5,190/- shall be collected as processing fee. The remaining fees already paid during admission shall be refunded.
- If the admitted candidate cancels his / her seat after closure of Industry sponsorship quota admissions process for the academic year 2026-27, the candidate forfeits the fees already paid and in addition, he /she has to pay an amount of Rs.5,190/- towards processing fee.
- Hostel facility shall be provided subject to the availability of accommodation.
- The University reserves all rights to review the fees from time to time and to change the no. of seats under this quota.
